One of the objectives of the European Union in the area of research is to create a European, open, transparent and attractive labour market for researchers. To this end the European Commission has launched a number of initiatives which promote this objective. These initiatives need to be linked through a common brand name which can support this vision and works as an umbrella: EurAxess. By creating a global brand name and visual identity for the European Researcher's Mobility Portal, the ERA-MORE network, the Charter & Code and ERA-Link, awareness amongst the main target groups, such as researchers, universities, research institutes, companies employing researchers, political authorities, etc. will be strengthened.

Wording. EurAxess clearly adds a European dimension to the name. It evokes access to a new world.

The spelling gives it a fresh, young and dynamic feel. The open letter “e” at the beginning of the word symbolises the initiatives’ openness.

When pronounced in English it adds a personalised and direct approach.

Logo. Three coloured circles complementing each other and symbolising different areas of competence of the initiatives.

EurAxess unites them, through an open link. The circles also allude to the representation of a molecule or thinking bubbles, referring to the main target group.

The roundness of the circles symbolises easiness and smoothness.

Tagline. The tagline addresses the primary target group. Mobility is one of the key concepts of the initiative and is taken to a wider context by using the word “motion”.

The tagline also alludes to emotions, often linked to finding a new job or dealing with one’s rights.

The EurAxess logotype will be used on different off - and on-line materials in a number of ways. In order to fit perfectly into any support, there are two different variations that can be used.

The preferred version is the vertically stacked logo (A).
The horizontal stacked logo (B) should be used to tackle space constraints, such as for the internet.
The DOs and DON'Ts for each logo are described in the next pages.


The logo should always be isolated on the background.
The minimum open space between the logo and any other element is indicated above.
The minimum space surrounding the brand mark is defined by the height of the letter "X". No framing is allowed.

The logo is centred around specific geometric axes.
The graphic elements are perfectly in balance with the text elements.
The tagline is aligned with the word EurAxess.



They cluster together to form a strong bond.


